

MODEL RELEASE FORM

In consideration of my engagement as a model, and for other good and valuable consideration herein acknowledged as received, I hereby grant the following rights and permissions to Daniel Mozzes Design, LLC ("Designer"), his heirs, legal representatives, and assigns, those for whom Designer is acting, and those acting with his authority and permission, including Fashion Under the Stars partner organizations the Downtown Albany Business Improvement District, Pearl Street Pub, the City of Albany, and all employees and agents of said partner organizations.

They have the irrevocable, perpetual and unrestricted right and permission to take, use, re-use, publish, and re-publish photographic portraits of me, or photographs in which I may be included, in whole or in part, composite or distorted in character or form, without restriction as to changes or alterations, in connection with my own or a fictitious name, or reproductions thereof in color or otherwise, made through any medium, at his studios, the Fashion Under the Stars event, or elsewhere, and in any and all media now or hereafter known, specifically including but not limited to print media and distribution over the internet for illustration, promotion, art, editorial, advertising, trade, or any other purpose whatsoever.

I specifically consent to the digital compositing or distortion of the portraits or pictures, including without restriction any changes or alterations as to color, size, shape, perspective, content, foreground or background. I also consent to the use of any published material in conjunction with such photographs.

I hereby waive any right that I may have to inspect or approve the finished product or products, the advertising copy, or other matter that may be used in connection with them or the use to which they may be applied. I understand that the images of me may be used in public service advertisement to promote anything. I hereby agree that my appearance in any photographs and at the Fashion Under the Stars event will be offered at no charge to Designer or his partner organizations, agents, and employees.

I hereby release, discharge, and agree to hold harmless Designer, his heirs, legal representatives, and assigns, and all persons acting under his permission or authority or those for whom he is acting, including employees and agents of the Downtown Albany Business Improvement District, Pearl Street Pub, or the City of Albany, from any liability by virtue of any blurring, distortion, alteration, optical illusion, or use in composite form, whether intention or otherwise, that may occur or be produced in the taking of such photographs or in any subsequent procession of them, as well as any publication of them, including without limitation



any claims for libel or violation of any right of publicity or privacy. In addition, I agree to defend, indemnify, and hold harmless Designer, the Downtown Albany Business Improvement District, Pearl Street Pub, the City of Albany, and their employees, agents, and assigns, from and against all claims, damages, losses, and expenses (including reasonable legal fees) arising out of my appearance as a model at the Fashion Under the Stars event, be they intentional or unintentional acts or omissions by me, or acts of God.

I understand that I will function as an independent contractor under the terms of this agreement and shall not be considered an employee or agent of Designer, the Downtown Business Improvement District, or Pearl Street Pub.

I hereby warrant that I am 18 years or older, and have the right to contract in my own name. I have read the above authorization, release, and agreement, prior to its execution, and I am fully familiar with the contents of this document. This document shall be binding upon me, my heirs, legal representatives, and assigns.
